



**A RESOLUTION OF NEWTOWN TOWNSHIP,  
DELAWARE COUNTY, COMMONWEALTH OF PENNSYLVANIA,  
APPROVING INTER- MUNICIPAL TRANSFER OF RESTAURANT LIQUOR LICENSE  
R-11238 INTO NEWTOWN TOWNSHIP FROM ANOTHER LOCATION  
IN DELAWARE COUNTY, PENNSYLVANIA**

**Resolution No. 2017 - 13**

**WHEREAS**, Act PL-90, art. IV, section 461 ("the Act"), as amended, (47 P.S. Section 4-461, et seq.), which amends the Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code provided sales of liquor, malt or brewed beverages are legal in the municipality receiving the license; and

**WHEREAS**, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the liquor license prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

**WHEREAS**, the Liquor Code stipulates that, prior to adoption of a resolution by the receiving municipality, at least one public hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant's intent to transfer a liquor license into the receiving municipality; and

**WHEREAS**, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality; and

**WHEREAS**, Acme Markets, Inc., has requested the approval of the Board of Supervisors of Newtown Township for the proposed transfer of Pennsylvania restaurant liquor license no. R-11238 from Baltimore Pike Assoc., Inc., formerly located at 403 W. Baltimore Avenue, Clifton Heights Borough, Delaware County, Pennsylvania to Acme Markets, Inc., at their premises located at 3590 West Chester Pike, Newtown Square, Newtown Township, Delaware County, Pennsylvania with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board.

**NOW THEREFORE**, the Board of Supervisors of Newtown Township does hereby resolve:

1. That the Board of Supervisors held a public hearing on March 27, 2017 and received comments and recommendations of interested individuals residing within the Township concerning the proposed liquor license transfer; and
2. That the Board of Board of Supervisors of Newtown Township following the public hearing, by this Resolution, hereby approves the transfer of Liquor License no. R-11238 from Baltimore Pike Assoc., Inc., formerly located at 403 W. Baltimore Avenue, Clifton Heights Borough, Delaware County, Pennsylvania to Acme Markets, Inc. and its premises located at 3590 West Chester Pike, Newtown Township, Newtown Square, Pennsylvania with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board.
3. That the proposed license transfer is subject to further approval by the Pennsylvania Liquor Control Board.
