**AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF
NEWTOWN, COUNTY OF DELAWARE, COMMONWEALTH OF
PENNSYLVANIA, CHAPTER 165 ENTITLED "VEHICLES AND
TRAFFIC" TO FURTHER RESTRICT PARKING ALONG PA 252**

WHEREAS, Township Code Section 165-13(A)(6) restricts parking at all times along both sides Newtown Street Road (SR 252) between West Chester Pike and Caley Road, and Section 165-13(A)(7) restricts parking at all times along both sides Newtown Street Road (PA 252) between West Chester Pike and Mary Jane Lane; and

WHEREAS, the Township has since determined that in order to protect and protect the health safety and welfare of the Township residents parking should be restricted along both sides of PA 252 for its entire length through the Township.

NOW, THEREFORE, the Township of Newtown hereby **ORDAINS** that:

Section 1. The Code of the Township of Newtown Chapter 165, Vehicles and Traffic, shall be amended to make the following changes to Section 165-13:

§165-13 Specific Parking Restrictions

A. Prohibitions at all times. No person shall park or permit a vehicle to stand in those sections or zones of the following highways of the Township as are hereinafter set forth:

1. The north side of West Chester Pike between the Marple Township boundary line and Radnor Drive; and between Surrey Drive and Clyde Lane.
2. Both sides of Munger Road from Newtown Street Road to Clyde Lane.
3. Both sides of North Line Road from the north side of West Chester Pike a distance of 200 feet to the north.
4. South side of West Chester Pike between Bryn Mawr Avenue and Bishop Hollow Road.
5. Northerly side of Media Line Road from Marple Township line to the westerly boundary line of Valley View Acres.
- ~~6. Both sides of Newtown Street Road from West Chester Pike to Caley Road, formerly known as "Tyson Road."~~
- 7.6. Both sides of Pennsylvania Route 252 (Darby-Paoli Road, N. Newtown Street Road and S. Newtown Street Road) between the northern Township line and the southern Township line. ~~West Chester Pike and Mary Jane Lane~~

- ~~8~~.7. Both sides of Valley View Lane from West Chester Pike to Mulberry Lane.
- ~~9~~.8. Both sides of Smedley Lane from West Chester Pike to School Lane.
- ~~10~~.9. Alice Grim School.
- (a) Both sides of Bishop Hollow Road from West Chester Pike to the Alice Grim School entrance.
 - (b) North side of Bishop Hollow Road from Alice Grim School entrance to Wisteria Drive.
 - (c) South side of Bishop Hollow Road from a point 210 feet west of School Lane to a point 175 feet east of Wisteria Drive.
- ~~11~~.10. The west side of Clyde Lane from the north side curb line adjacent to the paved roadway of the West Chester Pike northerly for a distance of 272 feet.
- ~~12~~.11. Both sides of Radnor Drive between West Chester Pike and Hilltop Road.
- ~~13~~.12. Both sides of the road known as "St. Albans Circle."
- ~~14~~.13. West side of St. Albans Avenue from West Chester Pike to Chapel Road.
- ~~15~~.14. South side of Hilltop Road between Rodney Road and Radnor Drive.
- ~~16~~.15. South side of Woodcrest Avenue from St. Albans Circle to a point 225 feet east thereof to the end of the business section. *Editor's Note: Original Subsection A(17) which immediately followed this subsection, was repealed 6-9-1980 by Ord. No. 1980-10*
- ~~17~~.16. West side of Clover Lane from West Chester Pike in a southerly direction to the end of Clover Lane.
- ~~18~~.17. West side of Earles Lane from Radnor Township line to a point on Earles Lane which is 3,175 feet southwest from Radnor Township line.
- ~~19~~.18. South side of Caley Road from Newtown Street Road easterly to a point 30 feet east of Tyson Road.
- ~~20~~.19. All the cul-de-sac's in the Township.
- ~~21~~.20. Both sides of Valley View Lane for a distance of 175 feet north of Media Line Road.
- ~~22~~.21. East side of North Line Road between the north side of West Chester Pike and a point located on the east side of North Line Road 260 feet north of the north side of West Chester Pike.
- ~~23~~.22. West side of North Line Road between West Chester Pike and Delmont Road.

- ~~24~~.23. West side of Delmont Road from North Line Road to a point on the west side of Delmont Road, a distance of 120 feet north from North Line Road.
- ~~25~~.24. The west side of St. Albans Avenue from St. Albans Circle north toward Winding Way.
- ~~26~~.25. The north side of Winding Way from the east side of Newtown Street Road for a distance of 1,270 feet to the east.
- ~~27~~.26. The south side of Winding Way from the east side of Newtown Street Road for a distance of 550 feet to the east.
- ~~28~~.27. The south side of Winding Way commencing 905 feet from the east side of Newtown Street Road and continuing for a distance of 365 feet to the east.
- ~~29~~.28. The east side of Clyde Lane commencing at a point 187 feet from the north side curb line adjacent to the paved roadway of the West Chester Pike northerly to Munger Lane.
- ~~30~~.29. The south side of Munger Lane from the west side of Newtown Street Road to Clyde Lane.
- ~~31~~.30. The north side of Munger Lane from the west side of Newtown Street Road to Clyde Lane.
- ~~32~~.31. The north and south sides of Mary Jane Lane, commencing at the west side of South Newtown Street Road and extending westerly, on each side, for a distance of 280 feet.
- ~~33~~.32. The north and south sides of Gradyville Road commencing at the Township boundary line with Edgmont Township and extending easterly on each side to a point 300 feet east of Hunter Run. Both sides of Llangollen Lane extending from Gradyville Road to its cul-de-sac.
- ~~34~~.33. Both sides of Roe Lane from West Chester Pike to School Lane.
- ~~35~~.34. On the west side of Barren Road from West Chester Pike 250 feet north.
- ~~36~~.35. On the north side of West Chester Pike extending from the Fox Trail Farm property line east for a distance of 1,070 feet. *Editor's Note: Original Subsection A(39) which prohibited parking on the south side of Rhoads Avenue from St. Alban's Circle easterly for 300 feet, as amended, was repealed 7-13-1992 by Ord. No. 1992-4.*
- ~~37~~.36. The east side of Northwood Road from a point 487 feet south of the southerly curb line of Dutton Road to a point 603 feet south of the southerly curb line of Dutton Road.
- ~~38~~.37. The southerly side of Rhoads Avenue from St. Alban's Circle to the northern side of West Chester Pike.

~~39.38.~~ The north side of Chapel Road to a point 140 feet from the easterly curb line of Newtown Street Road.

~~40.39.~~ The south side of West Chester Pike from the westerly curb line of Ellis Avenue for a distance of 200 feet in a westerly direction from the curb line of Ellis Avenue.

~~41.40.~~ The south side of Bishop Hollow Road from the easterly curb line of Campus Boulevard to a point 450 feet from the westerly curb line of Ellis Avenue.

~~42.41.~~ Southerly side of Brookside Road from Ridgefield Road to Bryn Mawr Avenue.

~~43.42.~~ Westerly side of Media Line Road from Mulbeny Lane to a point 230 feet north on Media Line Road.

Section 2. Effective Date. This Ordinance shall be effective upon its adoption by The Township of Newtown.

Section 3. Repealer. All ordinances, resolutions or parts thereof inconsistent herewith are repealed, rescinded, canceled and annulled to the extent of such inconsistency.
